# *2017 Instructions for Completing an Application for Campership Assistance for Camp Acahela Cub Scout Resident Camp or Cub Scout Day Camp*

## **Philosophy**

*The Northeastern Pennsylvania Council, Boy Scouts of America, believes that no Scout should be prevented from attending summer camp because of financial need. We also believe that the Scout should help pay a portion of his own way to camp. Unless extraordinary circumstances exist, we expect that parents or guardians, Pack, and chartering organization will also assist in the funding. And while it is not the intention of the Council to completely subsidize a camp fee, we are committed to making the necessary arrangements so that all Scouts can come to camp.*

## **Criteria**

- Registered Cub Scout in the Northeastern Pennsylvania Council
- Attending Camp Acahela or a Northeastern PA Council Day Camp
- Demonstrated financial need (which may include official documentation/proof)
- Approval of Pack leader, and Chartered Organization Representative or Committee Chair

## **Procedure**

*Please follow all steps as directed below. Incomplete applications will be returned.*

- Cub Scouts and parents for whom the cost of summer camp is a financial burden speak with their Pack leader.
- Pack Leader identifies opportunities (money-earning projects) to help the Cub Scout raise funds for camp.
- Parents/guardians and the Cub Scout identify how much they are able to pay toward the camp fee.
- The Pack leadership and Pack Committee provide financial assistance as they are able.
- The Pack leadership appeals to the Chartering Organization for additional support.

*Whenever possible, the Cub Scout, parent/guardian, Pack, and Chartering Organization should make arrangements to fund each Cub Scout's way to camp. After some contribution has been made from these sources (or explanation of extraordinary circumstances) the Council will consider providing additional funding.*

- The parent/guardian, Pack leader, and Chartered Organization Representative or Committee Chair complete and sign the attached form. Applications with missing signatures will be returned.
- The parent/guardian attaches **proof of financial need**. (Official documentation: Free/Reduced School Lunch, WIC, Public Housing, CHIP Health, Food Stamps, PA Access, Medical/Disability, SSI, or other.)
- Pack leader submits completed applications to the Council Service Center. **Deadline is April 15th.**
- Based on stated need and funds available this year, the Council Camping Committee will issue camperships for a specific amount. Generally, camperships are limited to at most, one half of the total camp fee.
- The Council Camping Director will notify the Pack leader and parent/guardian of the amount of the campership in writing no later than June 1st.
- The due date for the discounted camp fee is generally extended beyond the May 15 deadline for any Scout who submits an application for campership assistance. The correspondence will specify the due date for discount.
- The amount of the campership will be credited in the Cub Scout's name to the Pack's summer camp account.

## **Please Note:**

- ~ Camperships are not transferable or refundable.
- ~ These type of camperships are generally not available for Parent & Pal Weekends, however requests for assistance for these weekends may be made separately using the Council's general 'Financial Assistance Request Form.'
